### LEGALASE EXPLAINER

**TRANSFER / BOND TARIFF FEE** – a recommended fee set every year by the Law Society of South Africa. This fee is payable by the buyer and negotiable depending on if your are a repeat client.

**DEEDS OFFICE FEE** – charged by the Deeds Office to register the transfer / bond. This fee is also payable by the buyer and is set by the Government every year and cannot be changed by us.

**ADDITIONAL COSTS** – include disbursements (payments that we make to 3<sup>rd</sup> parties on your behalf) and additional fees for legal services outside the tariff fee (e.g. FICA compliance). These costs are not negotiable, will depend on the type of transaction, and will differ if you are the seller or the buyer.

#### **Examples include:**

- Posts & Petties to cover costs of copies and postage.
- FICA to verify your identity and conduct risk rating checks.
- Property Searches to verify the owner and get legal details.
- Rates Clearance Certificate paid to the municipality for 3 months advanced rates that must be paid before registration.

**N.B.** This is not shown here as it is calculated separately.

TRANSFER DUTY – a tax levied on transfers of property that is calculated by & paid to SARS.
